Does your Swimmer have any specific Goals for the 2008 Summer Swim Season?

The Greater Richmond Aquatic League is an organization of approximately 12,000 individuals, composed of swimmers, coaches, and families, whose aim is to promote and participate in the sport of summer swimming. GRAL provides an opportunity for young people to compete against others of their own ability at various skill levels, in an atmosphere of fair play and good sportsmanship.

Good sportsmanship is of primary importance. Respectful behavior on the part of swimmers, coaches and parents should be displayed at all times and places. Team membership is both an honor and a responsibility and unsportsmanlike conduct will not be tolerated.

In order to ensure fair competition, each Swimmer must report Best Times from any other competitive swimming (ie NOVA, YMCA, TRAC...) for which (s)he has swam since June 1, 2007. These times must be delivered to the TVW Computer Representative by June 1, 2008. GRAL will assess a \$50 fine for each failure to accurately document Best Times. **These fines are the responsibility of the Family, not the TVW Swim Team.**

Each meet requires approximately 125 Volunteers. **At TVW, each Family is responsible for volunteering to work a minimum of four(4) meets.** The TVW Swim Team Committee will post the Volunteer schedule prior to the start of the Season. Once assigned a role, the Family is responsible for completing that obligation, or finding someone to complete that role for the Team. Failure to complete your assigned obligation may result in your swimmer(s) being excluded from future meets/Team Activities.

Set-Up(5 required, Home Meets only) – Assists in preparing the Pool and Deck for the Meet. **Must arrive by 4:30pm.**

Parking Lot Attendant(1 required, Home Meets only) – See that entrance and parking lot are well marked and people know where to park. **Must arrive by 5:30pm.**

Announcer(2 required, Home Meets only) – Uses microphone to call Swimmers, make general announcements.

Head timer(2 required, Home Meets only) – Responsible for all Timers.

Timer(9 needed for each Meet) – Use a stop watch to time the swimmer in the assigned lane for each meet.

Runners(4 required, Home Meets only) – Collects time cards from Timers/Referee and delivers to the Head Table Worker.

Heat Awards (2 required, Home Meets only) – Present Heat Winners with prize.

Data Entry Assistant(2 required for each Meet) – Assist Computer Rep. to enter all Swimmer’s times into software.

Table Worker(6 required for each Meet) – Sorts/checks time sheets, prepares/files ribbons for swimmers.

Concessions(6 required, Home Meets only) – Assists with the preparation, selling, clean-up of Concessions.

Tear Down(4 required, Home Meets only) – At the end of the Meet, replaces equipment to prepare the pool for the next day.

Certified Positions – Referee, Strokes and Turn Judge, Starter, Clerk of Course, Computer Rep., Meet Director, Head Table Worker, Scorer. See the Parent Representative if you are interested in completing GRAL training for a Certified position.
